**ORDER**

Whereas in exercise of powers under the Epidemic Diseases Act, 1897, the Government of Punjab has already issued the Punjab Epidemic Diseases, COVID-19 Regulations, 2020 for the containment and prevention of the spread of COVID-19.


In view of the emergent situation arising out of the spread of COVID-19, it is anticipated that the public infrastructure may be over-burdened with various quarantine, treatment and containment measures to be implemented to meet the exigency of the situation. Therefore, considering the current situation, the below listed reserved treatment packages in Government hospitals under Ayushman Bharat - Sarbat Sehat Bima Yojana (AB-SSBY) pertaining to obstetrics and gynaecology i.e. deliveries, high-risk deliveries and cesarean-section are hereby de-reserved with immediate effect, thereby allowing the treatment of the below mentioned packages in the empanelled Private hospitals under AB-SSBY without any need of taking referral from the Government facilities.

- i. Caesarian Delivery
- ii. High risk delivery: Pre-mature delivery
- iii. High risk delivery: Expected Gestation at delivery less than 35 weeks
- iv. High risk delivery: Mothers with eclampsia or imminent eclampsia
- v. High risk delivery: Obstructed labour
- vi. High risk delivery: Major Fetal malformation requiring intervention immediately after birth
- vii. High risk delivery: Mothers with severe anaemia (<7 g/dL)
- viii. High risk delivery: Other maternal and fetal conditions as per guidelines- Such as Rh haemolytic disease, uncontrolled diabetes, severe growth retardation etc that qualify for high risk delivery etc.
- ix. Normal Delivery
- x. Caesarian hysterectomy

The above packages are to be booked under "Unspecified Package U-100" of the health benefit packages under Ayushman Bharat - Sarbat Sehat Bima Yojana. The detailed list of packages with rates is enclosed at Annexure-A and displayed on the website: [www.shapunjab.in](http://www.shapunjab.in).

Owing to the urgency of the matter, this order is being passed ex-parte, in public interest, coming in force with immediate effect and shall last till the State is declared COVID-19 free, followed with subsequent withdrawal orders.

This order shall be promulgated by giving press note for publication in the newspaper and through public announcement system through DPRO at District level.


